Successful completion of this stand-alone short course could earn exemption from Management II A if the participant subsequently wishes to and is eligible to enter the BCom degree programme.

### ENTRY ADMISSION REQUIREMENTS

- A first degree or equivalent qualification, or
- Matric which meets Wits Plus BCom entry requirements, or
- A three year National Diploma in a relevant area

### OBJECTIVES

To introduce students to:

- Alternative theories of management
- Role of the manager
- Comparative and international management
- Management of the public sector
- Management of change
- Planning, leading directing and controlling
- Organisational behaviour including motivation, performance and group and team work processes.

### OUTCOMES AND COMPETENCIES

Students will be expected to demonstrate an understanding of the roles and functions of the different aspects of management as listed above.

### METHOD OF EVALUATION

Submission of written assignments and tests and a 3-hour examination. Assignment/tests comprising the course work carry a 50% weighting and the exam carries a 50% weighting.

## METHOD OF PAYMENT
